<u>Car Parking for the Disabled and Blue</u> <u>Badge Holders in the School</u> <u>Grounds</u> <u>Guidelines for School</u>

Date: July 2020

Policy review dates: This policy will be reviewed under the following circumstances

- A significant change to the layout of the school and its grounds.
- Government law and guidance changes.

Updated: September 2020 (COVID restrictions for use of school car park for children to line up.

Updated: March 2021, children returning to school - no changes

When school timings return to the original timings (all children start at 08:40 and finish at 15:20 with no staggered start and end times) this policy will be reviewed.

The guidelines below refer to The Blue Badge scheme and Blue Badge holders. However several points apply to all users of the car park.

The school will abide by the legal obligations to make reasonable adjustments for disabled people as stated in the Equality Act 2010. It states that service providers (school) are to take reasonable steps to ensure that disabled people do not find it impossible or unreasonably difficult, to enjoy the service on the same basis as non-disabled people.

A designated car park space is defined as a marked disabled bay or other car park space allocated by the school.

The guidelines have been informed by the Department of Transport's, "Blue Badge Scheme: Rights and responsibilities in England."

1. A Blue Badge is intended to help the disabled to park close to school, either as a passenger or driver.

- 2. The Blue Badge is allocated to the holder and not the vehicle. It is for the holder's use and benefit only.
- 3. The Blue Badge holder may be the driver of the vehicle or a passenger.

4. The Blue Badge is intended for an on-street parking only. Off street car parks, such as those provide in local authority, schools or hospital car parks etc., are governed by separate rules outlined in these guidelines.

5. The school car park is private property. The use of the School's car park for both Blue Badge holders, and the non-disabled is at the School's discretion. By law, Blue badges do not apply on private land.

6. The school retains the right to deny access to any member of the public, particularly if there are any staff and pupil safeguarding issues or the users are misusing the concessions and privileges.

7. The car park is essentially used by staff and they are authorised users.

8. Parents, who are not disabled and Blue Badge holders, should not use the car park.

9. The school provides two car parking spaces for the disabled and Blue Badge holders.

Update September 2020: These designated disabled parking bays have now been reallocated to the back of school as children will be lining up in the current disabled parking bay areas.

10. If there are registered disabled pupils in school and several staff/parents who are themselves registered disabled then if both designated spaces are occupied by Blue Badge holders, other vacant designated parking spaces may, at the school's discretion, be allocated temporarily, provided other vehicles, exits and entrances to the building are not blocked.

11. Holders of Blue Badges are asked to make themselves known to the school. They are obliged to identify themselves to members of staff in school, if they wish to use the car park regularly and they will be provided with a copy of these guidelines.

12. The School reserves the right to challenge any member of the public who wishes to gain access to the School's car park and this includes Blue Badge holders who are drivers or passengers of vehicles.

13. Holders are asked to display the Blue Badge when they park in the school's car park, where it can be clearly read through the front windscreen. The badge must be displayed if you (the holder) are travelling in the vehicle in the car park as a driver or passenger, or if someone is collecting you (the holder) or dropping you (the holder) off and needs to park at the place where you, (the holder) are being collected or dropped.

14. Blue Badge holders are reminded that it is a criminal offence to misuse the badge on the public road. This includes people, other than the badge holder, taking advantage of the parking concessions and privileges provided under the scheme. The School will not condone any misuse of the badge within the school grounds. (Please refer to the legitimate use of the Blue Badge at the end of these guidelines).

15. Blue Badge holders are asked to note that the School reserves the right to refuse admission to the car park if the Blue Badge holder is either not present in the vehicle or is not a pupil in school.

16. If you (the holder) are using the parking concessions as a passenger, we remind you that it is your responsibility to make sure that the driver is aware of the School's guidelines.

17. The Blue Badge holder is reminded not to use the badge to allow non-disabled people to take advantage of the benefits and concessions while you, the badge holder is sitting in the vehicle. (Please refer to the legitimate use of the Blue Badge at the end of these guidelines).

We will strive to be fair-minded with all Blue Badge holders, but there may be occasions when we will refuse access to the car park. Specifically if:

1. The Blue Badge holder is not present in the vehicle as a driver or as a passenger.

2. The Blue Badge holder has not previously identified themselves to the school staff.

3. The Blue Badge holder is not visiting on school business.

4. The Blue Badge holder or driver has been frequently challenged for reasons outlined below.

5. If the Blue Badge holder is trying to access school during the lock down times 08:10 – 09:00 and 14:45 – 15:30 every day. This means if a blue badge holder wishes to access the school car park then they **MUST** arrive before 08:10 and wait until 09:00 to exit the school car park and arrive before 14:45 and wait until 15:30 to exit the school car park. There will be times when staff have to access or exit the school car park during the lock down times. Reasons for this include, a safeguarding issue at school, an emergency on the school site (police, fire, medical emergency on site), a natural disaster, a flood or chemical spill, bomb threats or terrorist attack, a criminal act, a missing child, individuals threatening pupils, parents or staff or any other reason at the Headteachers discretion.

We would challenge access to the car park if:

1. The vehicle containing the Blue Badge holder is blocking access to the building for example, blocking gates to the compound, blocking the doorway to the sub-station etc.

2. The occupants of the vehicle including the Blue Badge holder are breaking a School/Local Authority rule or regulation for example: smoking in the vehicle, playing loud music, causing a nuisance or abusing staff, children, parents or authorised visitors. If the Blue Badge holder is trying to access school during the lock down times of 08:10 – 09:00 and 14:45 – 15:30 every day.

3. The Blue Badge is not clearly displayed in the vehicle.

4. Where the Blue Badge holder leaves the school grounds, leaving the vehicle on the car park.

Legitimate Use of the Disabled Car Park Spaces by Blue Badge Holders:

Vehicles will be allowed access to use the designated disabled car park spaces for any of the following reasons:

1. Where the Blue Badge holder is a pupil, member of staff, trainee, governor or authorised visitor, their vehicle can use the designated car park space for collecting or dropping off purposes.

2. Where the Blue Badge holder is a pupil, member of staff, trainee, governor or authorised visitor their vehicle can use the designated car park space for waiting purposes.

3. Where the Blue Badge holder is not as mentioned in points 1 and 2 above, but is the driver, can use the designated car park space for collecting or dropping off purposes.

4. Where the Blue Badge holder is not as mentioned in points 1 and 2 above, but is the driver, their vehicle can use the designated car park space for waiting purposes.

5. Where the Blue Badge holder is visiting on school business for example meetings with staff, or concerts etc., their vehicle can use the designated car park space.

With reference to points 3 & 4 above and concerning pupils and non-disabled drivers and additional passengers:

In the interests of fairness, the School reserves the right to refuse access to vehicles containing the Blue Badge holder, if a non-registered disabled parent/carer or authorised adult is the driver or additional passenger in the vehicle. This exception is on the grounds that we would assume the non-disabled driver or passenger would be

able to collect, drop off or wait for their child in similar ways to other non-registered disabled parents/carers or authorised adults and not benefit from the concessions and privileges allowed to legitimate users.
